

DARK & MYSTERIOUS FORCES ENGULF J6

Let's start with the shooting death of J6 protester Ashli Babbitt.

Independent journalist Taylor Hansen who witnessed the events says that Babbitt delivered the face-punch less than 10 seconds before Lt. Byrd, the Commander at the scene, issued the kill shot with no verbal warning.

“Lieutenant Byrd declined to provide a statement until he could consult an attorney.”

On the surface that seems odd after all Officer Byrd just shot and killed a citizen. But what makes it even stranger is that apparently Officer Byrd never spoke to investigators.

According to Real Clear Investigations:

“MPD (Metro Police Department) did not formally interview Lt. Byrd,’ deputy D.C. MPD communications director Kristen Metzger said. And, ‘He didn’t give a statement while under the U.S. Attorney’s Office investigation.’”

In April 2021, within just four short months of the shooting, Byrd was cleared of criminal wrongdoing by the Justice Department.

Nota bene: Wow! Fast work everybody. In all the sensationalist news reports one thing was overlooked: The “Justice Department” declined to impanel a grand jury to hear evidence, a stark departure from other lethal police-shooting cases involving unarmed citizens.

Troy Nehls, a Texas Republican and former sheriff concurs that the investigation of Lieutenant Byrd was scanty:

“Many officers in the USCP (U.S. Capitol Police) I have spoken to believe the investigations of Lt. Boyd were dropped because of his position and other political considerations.”

After all charges were dropped Byrd spoke publicly on the heavily promoted 8/27/2021 edition of the NBC Nightly News which curiously presented only his version of the events.

“In defending his actions on television, Byrd revealed things he evidently wouldn’t tell investigators, including his claim that he shot as ‘a last resort’ and only after warning Babbitt to stop.”

Funny thing though. Documents discovered by Judicial Watch reveal that three police officers at the scene did not hear Byrd shouting any kind of warnings before he gunned down Babbitt.

<p>Sergeant [REDACTED] observed a white, female protester was climbing through an opened area where the glass pane had been knocked out. He heard a gunshot and this female fell backwards through the opening.</p> <p>The crowd on the other side of the barricaded east doors, began to step back and some put their hands in the air. Sergeant [REDACTED] observed Lieutenant Byrd step back just after hearing the gunshot. Byrd’s declaration that he “shot as a last resort” does not stand up to scrutiny.

Legal experts Geoffrey Alpert, Jeff Noble and Seth Stoughton commented in a September 9, 2021 edition of Lawfare their skepticism that Byrd acted appropriately even after watching his NBC interview that did not present witnesses who could refute Byrd's self-serving comments:

“The limited public information that exists raises serious questions about the propriety of Byrd's decision to shoot, especially with regard to the assessment that Babbitt was an imminent threat.”

“The facts speak truth. Ashli was ambushed when she was shot by Lt. Byrd. Multiple witnesses at the scene yelled, ‘you just murdered her.’”

Nota bene: None of these witnesses were interviewed on the 8/27/2021 NBC News show.

Shot as a last resort? Really?? The statement, “I shot as a last resort.” implies that Lt. Byrd must have felt threatened by Ashli Babbitt.

From Judicial Watch:

Sgt. Timothy Lively, one of the armed officers guarding the lobby doors from the hallway, later told officials investigating the shooting, “I saw him [Lt. Byrd] . . . there was no way that woman would’ve seen that.” Lt. Byrd, who was not in uniform, did not identify himself as a police officer or otherwise make his presence known to Ashli. Lt. Byrd did not give Ashli any warnings or commands before shooting her dead.

Nota bene: Officer Lively was not interviewed on the 8/27/2021 NBC News show.

During their investigation Judicial Watch discovered another controversial shooting involving Lt. Byrd when teenagers stole his vehicle in a suburban area. Byrd fired multiple shots at the fleeing vehicle but his shooting was so erratic that stray bullets struck the sides of nearby homes!

Now for the strange part. Six months later that same person was arrested in Salt Lake Utah for a fatal stabbing. After interviewing several witnesses Salt Lake police determined that the individual, identified as John Banuelos, acted in self-defense and was not charged.

While in police custody Banuelos told detectives three times that he was at the U.S. Capitol on January sixth:

"Yeah, I went inside and I'm the one with the video with the gun right here," Banuelos said.

Absurdly the FBI has not arrested or, as far as can be discerned, even interviewed Banuelos.

The RNC & DNC Pipe Bombs Farrago

According to the government this pipe bomb was left adjacent to a bench outside DNC headquarters at 8:00 PM Monday January 5, 2021, an area that has high pedestrian traffic yet somehow remained undiscovered for 17 hours until it was discovered the following day at 1:05PM.



Once Congressman Tom Massie obtained critical video footage of the DNC headquarters the government's version of the pipe bomb began to disintegrate.

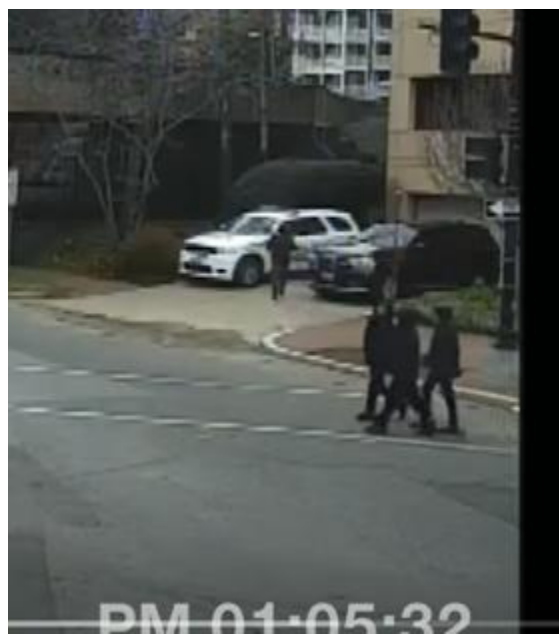
On J6 two vehicles are parked outside the DNC. The white one is the DC Metro Police and the dark vehicle is the Secret Service. You may be wondering what a Secret Service vehicle is doing at the DNC headquarters. The answer to that question only raises more questions. As we now know, VP-Elect Kamala Harris was not inside the U.S. Capitol on the day of pandemonium but rather was inside the headquarters of the DNC! It gets more intriguing. At time stamp 1:05:32 a man with a backpack is seen speaking to officers in the white vehicle afterwards he speaks with the Secret Service Agents in the black SUV. It has been confirmed that the man with the backpack is plainclothes US Capitol Police Officer.



At 1:07:29, a metro officer gets out of the Metro PD car. This is two minutes after the plainclothes US Capitol Police Officer approached the Metro PD car.

Watch the video from 1:07:27 to around 1:09:05 and take note of how nonchalant both the Metro officers and Secret Service officers are. They're strolling along apparently without a care in the world while a bomb is sitting in the bushes and ask yourself whether this is how you'd expect the Secret Service would respond to a discovery of a bomb right outside the building where vice president-elect Kamala Harris is situated?

At 1:09:48, we see a group of children cross the street and walk directly in front of the benches where the bomb is still sitting. Shouldn't they be warned that a bomb is underneath the bench? Evidently the secret service agents don't think so, instead they themselves walk right by the bench as well, seemingly without a care in the world. You can't make this stuff up!



Timestamp 10:15 shows a Capitol Police officer standing between the scooter and the bench taking a picture of the bomb.



Although the video soon ends here sources claim that afterward a robot was dispatched to the scene to dismantle the bomb.

On February 29, 2024 The Epoch Times reported that when the bomb disposal crew arrived to dismantle the bomb three cameras turned away from the DNC building preventing video documentation of their presence.

On February 28, 2024 a report from Declassified provided yet another video at the DNC headquarters on the same day but earlier in the morning. Notice that a vehicle is parked in the driveway that is being approached by a man walking a dog. The video shows the dog entering the vehicle presumably to sniff for a bomb. Afterwards the vehicle enters the garage.

Congressman Matt Gaetz held hearings concerning FBI retaliation of whistleblowers. With regard to the J6 events the Boston Field Office was unwilling to initiate a criminal investigation without evidence that a crime had been committed and demanded access to the 11,000 hours of J6 videotapes for them to examine. The Washington Field Office refused to turn them over with the explanation that there may be undercover officers and/or confidential human sources whose identity needed to be protected.

What makes this so mind blowing is that FBI agent Marcus Allen was terminated when he opined that the FBI may have had assets present on J6. It turns out that Allen held a security clearance for twenty years and at one time was awarded employee of the year award for the Charlotte Field Office. Prior to joining the FBI Allen served two tours in the Iraq war as a marine for which he was awarded the Navy Accommodation Medal and the Navy Achievement Medal.

Yet the mere suggestion that the FBI may have had assets at the U.S. Capitol on J6 was sufficient to challenge Allen's patriotism thus leading to the revocation of his security clearance.
